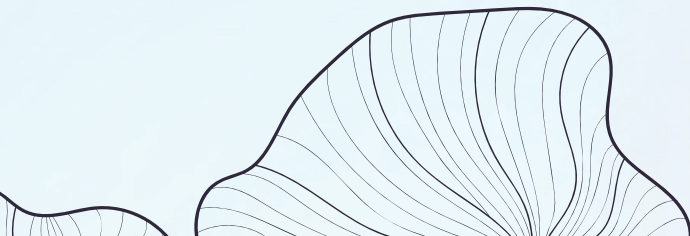

The Covington Art Fair is a high quality two-day community event featuring fine arts. The Fair is located at Covington Plaza, Fort Wayne's most prestigious shopping plaza featuring high fashion, specialty large shops, gourmet restaurants, a spa and much, much more.

## ELIGIBILITY

Each entry must be an unassisted, original work by the artist. Copies of other artists' works or published photographs are not acceptable. The Covington Art Fair is a family-oriented show and works to be exhibited should reflect this family atmosphere. Must be 18 years of age to enter.

## JURYING AND SELECTION PROCESS

Jurying is conducted by experienced art professionals and is based solely upon the quality of work as illustrated in digital images. **Do not send printed photos or examples of work.** A CD, thumb drive, or email to [glendas@asheragency.com](mailto:glendas@asheragency.com) containing four quality digital images (three images of your work and **one of your booth**), must be submitted with the application and jury fee. Label the CD/thumb drive with your name and medium. Digital images must clearly represent the style and quality of work intended for exhibition at the Covington Art Fair. CD/thumb drive will not be returned.

\*Twenty percent of show is jury exempt.

## SUBMISSION AND DEADLINE

Application, CD or thumb drive containing four digital images, **one must be of your booth**, and a non-refundable **\$30** jury fee are due **Monday, March 3, 2025**. All media and styles are encouraged to apply. Accepted artists will be notified by **April 11, 2025**. Please make checks payable to **Asher Agency**.

## CONTRACTS, FEES AND AWARDS

Artists may display only work in the media categories in which they are accepted and it must be comparable to work shown in submitted images. Artists are required to remain open for business from 10:00am - 5:00pm on Saturday, June 21 and 11:00am - 4:00pm on Sunday, June 22, 2025. Artists selected will be required to sign a contract with the Covington Art Fair specifying payments, requirements and liability. The signed contract and a booth rental fee of **\$300** will be due Friday, May 9, 2025.

## Accepted media categories include:

- **oil/acrylic painting**
- **textiles/wearable art**
- **watercolor**
- **pottery**
- **mixed media**
- **jewelry**
- **photography**
- **glass**

A Best of Show and 5 Awards of Excellence will be presented.

## BOOTH INFORMATION

Covington Plaza is an outdoor shopping area. Artists will be provided with a generous 10' x 10' space (Note: Artists must provide their own tents, display equipment, etc.). Information packets detailing all show and setup information and further site specifics will be sent upon receipt of booth rental fee and signed contract. **Boothsitters will be available.**
